Councilmember Mullins asked Ms. Quillen to contact the THS clubs, THS Band and the Green T's Choir to participate in the Veterans Celebration.

Councilmember Blankenship stated the Boy Scouts could walk in honor of a Veteran.

Councilmember Willis stated he would make a donation for a luncheon for the Veteran's.

Manager Wood stated that Sharon Thomas would possibly provide a trailer tractor for the Veteran's to ride on.

Dale Elswick, of 644 East Riverside Drive, came for Council concerning trucks parked on his property that are used for plowing snow in the winter. Mr. Elswick stated the vehicles are untagged and some are used on private property during the winter months.

Council stated they would look into the situation and get back with Mr. Elswick.

NORTH TAZEWELL WATER TANK

Manager Wood stated that the North Tazewell water tank was taken off line. Manager Wood advised the Town was working with the Health Department and the Department of Environmental Quality to either replace the water tank or to repair the tank.

Councilmember Blankenship asked how much it would cost to replace the tank.

Manager Wood stated it would cost \$150,000-\$200,000 to repair tank and a million dollars to replace with a new tank.

ROUTE 61 PROJECT

Manager Wood stated some the right-of-ways have been signed for the Route 61 Project and will be meeting with Lester Development concerning land donation for water and sewer taps.

DRY TOWN SEWER PROJECT

Manager Wood stated he was doing the final checklist for the Dry Town Sewer Project to start the project.

GRANT FOR LINCOLHSNIRE PARK

Manager Wood stated that Thompson and Litton have started the grant application for Lincolnshire Dam. Manager Wood advised grant money could be used for several projects at the Lincolnshire Park.

911 ADDRESSING

Tracie Lewis updated Council on the 911 addressing of the Town streets.

PRESENTATION OF FY 13 BUDGET

Manager Wood presented the FY 13 Proposed Budget to Council. A Public Hearing was set for the June 12, 2012 meeting.

Mayor Buchanan thanked the Finance Committee for their work on the Budget.
