## NEIGHBORHOOD WATCH PROGRAM

Chief Cooper stated that the Neighborhood Watch Program is more detailed than just having a meeting together with the neighborhood must towns have a full time employee that specialist in these programs. Neighborhood Watch Program has to 100% participation. Also, the number of crimes in the area determines if there is a need for a Neighborhood Watch Program. Chief Cooper checked on Fairground Road July 1996 to date and found 84 incidents – 44 incidents were drunk in public during the Tazewell County Fair. Chief Cooper stated the program can be done if there is enough interest in the neighborhood for the program.
