CALL TO ORDER

Mayor Buchanan called the meeting to order and opened with the pledge of allegiance.

Manager Day would like to request direction from the council for the upcoming budget. Staff has until March 15th to present requests for the 2016-2017 budget. We have raised water and sewer rates the last three years and last year we balanced the budget. The water fund is building and looking good. The rescue squad billing has been a big issue this year and we will have additional cost with the rescue squad because of having to provide health insurance. Our economy has been hit hard because of job loss in our area and it will affect our businesses in town which will then affect the revenue the Town collects, such as BPOL taxes. We are currently trying to work on tax incentives to offer businesses. We need to draw businesses in and make them want to come to the Town of Tazewell.
