Council Minutes

Special Called Meeting

August 17, 2017

The Tazewell Town Council met in a special called meeting at 6:00 a.m. in the Town Hall Council Chambers.

CALL TO ORDER

Mayor Buchanan called the meeting to order and lead the pledge of allegiance. Manager Day gave the invocation.

BPOL TAX DISCUSSION

Manager Day stated that at a prior meeting the council voted to raise retail business license rate from .15% to .3%. We have sent out letters to let businesses know. This will not take effect until January 2018. Manager Day recommends .3%. This will double our rate. He anticipates that other localities will be raising their rates as well. As an example, if a business made \$100,000.00 at the current rate of .15% they would pay \$150.00. If we went to .3% they would pay \$300.00 an additional \$150.00.

In 2017 for retail businesses we brought in \$41,469.94. In 2016 we brought in \$46,415.70.

In 2015 we brought in \$50,292.36. Councilmember Catron is concerned the higher rate compared to other localities will drive potential businesses away. He stated the business will not pay the increase the customer will because businesses will increase their price. Manager Day stated that we are not raising rates because we need the revenue but when a project comes up it would be good to have. He would like to plan ahead and not wait until things need done. Attorney Pyott asked when the last time the BPOL rates were raised. Executive Assistant

Brewster said she doesn't remember them ever being raised since she has been there and that has been 26 years. Councilmember Catron made a motion to lower the earlier approved rate of .3% to .25% for Financial/Professional. Councilmember Brown seconded the motion. On vote, Vice Mayor Mullins, aye; Councilmember Catron, aye; Councilmember Brown, aye; Councilmember Boyd, aye.

FRANCHISE DISCUSSION

Attorney Pyott stated that he received documents from Mike Tenck. Council voted at the last meeting to grant a three year franchise. Mr. Tenck sent an extension agreement to us instead of a renewal. This would remove all changes requested except the name change. If passed today it would not go into effect for 30 days. Attorney Pyott recommends to pass this. Councilmember Catron made a motion to extend agreement instead of renewing it. Councilmember Brown seconded the motion. Vice Mayor Mullins asked if this meant the schools would get to keep their current package, it was answered yes they would. On vote, Vice Mayor Mullins, aye; Councilmember Catron, aye; Councilmember Brown, aye; Councilmember Boyd, aye.
