The chairperson will ultimately decide where vendors will be placed. We reserve the right to accept or reject any vendor at any time. Please indicate in the space below any special requirements or requests. Committee volunteers will distribute booth assignments beginning at 7:00 a.m. in front of Tazewell County Courthouse. Liability insurance with a minimum of \$1 million is required with each application. Health Department information will be forth coming with confirmation of your payment and menu. We ask that you remain setup for the duration of the event and do not leave before your selected setup option.
