Consideration and award of ANY Grant is made at the discretion of the I/EDA of the Town of Tazewell. Certain businesses (including but not limited to adult entertainment establishments, automobile dealerships, car washes, convenience stores, gas stations, junk yards, non-traditional lenders, seasonal businesses, self-storage facilities) may not be considered for award eligibility by the I/EDA.
