CALL TO ORDER

DISCUSSION

ENTERPRISE ZONE

Manager Regon had prepared a presentation regarding the Virginia Enterprise Zone for the Town of Tazewell. She stated that Tim Danielson with Tazewell County had stated that if we wanted to make any changes to our zone, now was the time to do so. They reviewed the current zone and discussed areas to add or remove from the zone. In addition to what she had prepared it was suggested by IEDA Member Bales to add in the Grundy National Bank property, it was suggested by IEDA Member Smith to add Earl Keene's building on Riverside Drive that was previously Riverside Fashions. IEDA Member Bales suggests that we remove the property at the YMCA that houses their solar panels and reallocate that acreage to cover the Cox lot on Main Street. Manager Regon asked if anyone had any other discussion and was everyone in agreement with the changes they just set out for the enterprise zone. It was answered, yes, they are in agreement.

EBAG

NEW APPLICATION -BOHEMIAN GRAY

Manager Regon stated that Megan Muncy with Bohemian Gray, a new business opening on Main Street, has submitted an EBAG application and it is in the packet for review today. They reviewed it and the business plan submitted and it was decided to ask her to come to the August IEDA meeting.

PENDING AGREEMENTS-BEE NOODLED, WAYFARER, AND STINGERZ

Attorney Pyott stated that for Bee Noodled and Stingerz, we need a lease agreement for the businesses. We need The Wayfarer to update their application. It is suggested to have them lower the number of employees on their application. It is suggested they need to list 5 employees.

ONGOING PROJECT UPDATES

RAMEY LOT AND RIVERSIDE DRIVE PROPERTY

POTENTIAL IDEA: CANNERY

IEDA Chair Spivey and Manager Regon had a meeting with representatives from Tazewell County and they were discussing the idea of a cannery. Many years ago, there was a cannery in Tazewell County and it ultimately closed. It was stated that the newly owned IEDA property on Riverside Drive could be a potential location for a cannery and it could pair nicely with the farmers market across the street. This is just an idea that was being discussed.

FARMERS MARKET

GRANT UPDATE-AFID

We applied for the Agriculture and Forestry Industries Development (AFID) Grant and have now been awarded with \$28,244 to go toward the Clinch River Pavilion and Farmers Market project.

MISCELLANEOUS

TOWN OF TAZEWELL MOUNTAIN BIKING PROJECT

Manager Regon discussed the mountain biking project. She stated that we needed to have easements for the properties adjoining us. Attorney Pyott is going to prepare a draft and we will meet with property owners to discuss. Manager Regon is to send the lease agreement that is currently in place for the hiking trail to Attorney Pyott.

BILLY WAGNER PARK TRIBUTE

In an email discussion dated 6/18/25, a vote was needed to allow IEDA Chair Spivey to sign an authorization form for core drilling to take place in the Mini Park for the Billy Wagner statute. The IEDA now needs to ratify the vote.
