

Lincolnshire Lake AquaPark

Participant Rules and Regulations

ALL PARTICIPANTS UNDER THE AGE OF 18 must have a parent or Guardian sign the Participant Rules and Regulations and accompanying Waiver and Release, or access to the Lincolnshire Lake AquaPark ("AquaPark") will be denied. Additionally, EVERY PARTICIPANT UNDER THE AGE OF 14 MUST BE ACCOMPANIED BY AN ADULT who is responsible for participant's activities during participant's visit to the AquaPark. EVERY PARTICIPANT UNDER THE AGE OF 10 MUST BE ACCOMPANIED BY AN ADULT at all times while in the water and on the inflatables.

Once admitted to the AquaPark, strict adherence to these Rules and Regulations, including the instructions, requests, commands, etc., of the Town of Tazewell ("Town") employees supervising the AquaPark is required by all Participants. Failure to follow such instructions can lead to removal from the AquaPark without refund or readmission.

Weapons and sharp objects of any kind are strictly prohibited from the premises. Lincolnshire Lake AquaPark is a drug, alcohol and tobacco FREE facility. ABSOLUTELY NO DRUGS, ALCOHOL, TOBACCO OR VAPE PRODUCTS OF ANY KIND ARE ALLOWED AT THE AQUAPARK.

Once an admission bracelet has been purchased, there are NO REFUNDS - NO EXCEPTIONS. While The Town of Tazewell, specifically acting through its employees of the Tazewell Recreation Department, will make every reasonable attempt to keep the AquaPark open during posted hours of operation, the Town has the sole discretion and authority to suspend operations and/or close the AquaPark at any time for any reason it deems appropriate, including but not limited to inclement weather or the threat thereof. The Town also reserves the right to deny any person access to the AquaPark, or to revoke any Participant's admission to the AquaPark premises if he/she is jeopardizing his/own safe use of the AquaPark facility, or jeopardizes the safe use and/or enjoyment of the AquaPark by others as a result of his/her condition and/or behavior.

EVERY Participant using any of the AquaPark facilities and/or rental equipment MUST WEAR AN APPROVED LIFE VEST AT ALL TIMES WHILE IN THE WATER OR WHILE UPON ANY OF THE AQUAPARK EQUIPMENT.

The Town is not responsible for lost, broken, or stolen personal items while visiting the AquaPark.

The Town of Tazewell Recreation Department staff has the right and authority to remove anyone from the Aquapark without refund and possible suspension from future use of the AquaPark if the Rules and Regulations of this facility are not followed by any participant during his/her admission to the AquaPark.

Release and Waiver

I am aware and understand that use of the Lincolnshire Lake AquaPark and its attractions (AquaPark, Paddle Board/Kayak/Paddle Boats, etc.) may pose potentially serious risks of injury or death to any participants. I am aware of the intrinsic dangers of swimming and water related activities, and I understand that I may be injured or die as a result of my negligence or the negligence of others, or through no fault of myself or anyone else, because of the nature of the activities in which I am going to be engaged. By signing below I hereby acknowledge these dangers and knowingly and voluntarily assume the risk thereof, and further agree to waive or release any and all rights that I or my heirs might have to make a claim against the Town of Tazewell or its employees, agents, representatives, or successors and assigns, from any damages, injury, or death which I might sustain or which might occur as a result of my participation in activities at the AquaPark. Further, I agree to indemnify and hold the Town of Tazewell, its employees, agents, and successors and assigns, harmless from and against any claims which I might make, or which may be made on my behalf by others, or which might be made against me by others for personal injury to myself or others, or for any property damage whether to equipment or any other property, and for any claims of repairs that are needed that may arise or result from my use of the AquaPark facility.

I further acknowledge and understand that due to lifeguards not always being able to observe all activities or individuals at all times that the AquaPark is operating, that I am required to wear an approved life vest and assume responsibility for my own safety while using any of the AquaPark attractions.

By signing below, I acknowledge having read not only this Release and Waiver, but also the Lincolnshire Lake AquaPark Participant Rules and Regulations, that I agree to the terms and conditions set out in both, and that I am also acknowledging that by use of the AquaPark facilities my photograph may be taken and posted for promotional purposes and/or media coverage.
